DECISION ON ATTORNEY'S FEES AND COSTS¹

On April 1, 2022, Douglas Berman filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleged that he suffered a shoulder injury related to vaccine administration following an influenza vaccine he received on October 12, 2020. Petition, ECF No. 1. On June 2, 2025, I issued a decision finding Petitioner entitled to

compensation and awarding damages, following briefing and expedited Motions Day argument by the parties. ECF No. 33.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$22,506.77 (representing \$21,470.20 in fees plus \$1,036.57 in costs). Application for Attorneys' Fees and Costs ("Motion") filed November 3, 2025, ECF No. 40. Furthermore, counsel for Petitioner represents that no personal out-of-pocket expenses were incurred by the Petitioner. ECF No. 40 at 2.

Respondent reacted to the motion on November 5, 2025, indicating that he is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, 3 n.2, ECF No. 41. Petitioner filed no reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. The rates requested for work performed through 2025 are reasonable and consistent with our prior determinations and will therefore be awarded herein.

Regarding the time billed, I note this case required additional briefing regarding entitlement and damages. See Petitioner's Motion for Ruling on the Record Regarding Entitlement and Damages, filed April 30, 2024, ECF No. 28. Petitioner's counsel expended approximately 12.60 hours drafting the entitlement and damages brief. ECF No. 40 at 10-11. I find this amount of time to be reasonable and will award the attorney's fees requested. And all time billed to the matter was also reasonably incurred.

Furthermore, Petitioner has provided supporting documentation for all claimed costs. ECF No. 40 at 14-23. Respondent offered no specific objection to the rates or amounts sought. I find the requested costs reasonable and hereby award them in full.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. **Petitioner is awarded attorneys' fees and costs in the total amount of \$22,506.77 (representing \$21,470.20 in fees plus \$1,036.57 in costs) to be paid through an ACH deposit to petitioner's counsel's IOLTA account for prompt disbursement.** In the absence of a timely-filed motion for review (see Appendix B to the

Rules of the Court), the Clerk of Court shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
