## **DECISION AWARDING DAMAGES**<sup>1</sup>

On May 11, 2022, Marilyn Hartogh filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she suffered Guillain-Barré Syndrome (“GBS”) which meets the Table definition for GBS, after receiving an influenza (“flu”) vaccine on September 16, 2019. Petition at 1 ¶ 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On January 10, 2023, a ruling on entitlement was issued, finding Petitioner entitled to compensation for her GBS. On March 20, 2023, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded \$175,000.00, representing compensation for her pain and suffering. Proffer at 1. In the Proffer,

Respondent represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$175,000.00, representing compensation for her pain and suffering in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.<sup>3</sup>

**III. Form of the Award**

Petitioner is a competent adult. Evidence of guardianship is not required in this case. Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment as described below and requests that the Chief Special Master's decision and the Court's judgment award the following<sup>1</sup>: a lump sum payment of \$175,000.00, in the form of a check payable to petitioner.

**IV. Summary of Recommended Payments Following Judgment**

Lump sum payable to petitioner, Marilyn Hartogh: **\$175,000.00**
