DECISION ON ATTORNEY’S FEES AND COSTS¹

On May 31, 2022, Katherine Miller filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleged that she suffered a Table injury – shoulder injury related to vaccine administration (“SIRVA”) - as the result of influenza (“flu”) vaccine received on December 3, 2020. Petition at 1. On January 27, 2025, I issued a decision finding Petitioner entitled to compensation and awarding damages, following briefing and Expedited Motions Day argument by the parties. ECF No. 36.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$28,312.76 (representing \$27,154.30 for attorney's fees and \$1,158.46 in attorney's costs). Petitioner's Application for Attorneys' Fees, filed Apr. 8, 2025, ECF No. 43. In accordance with General Order No. 9, counsel for Petitioner represents that Petitioner incurred no out-of-pocket expenses. *Id.* at 2.

Respondent reacted to the motion on April 9, 2025, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, 3 n.2, ECF No. 44. Petitioner has not filed a reply.

The rates requested for work performed through 2025 are reasonable and consistent with our prior determinations, and will therefore be adopted.

I also note this case required additional briefing regarding entitlement and damages. See Petitioner's Motion for a Ruling on the Record Regarding Damages ("Motion"), filed Feb. 15, 2024, ECF No. 30; Petitioner's Reply to Respondent's Response to Motion, filed Mar. 27, 2024, ECF No. 33; Petitioner's Minute Entry, dated Jan. 27, 2025 (for January 24, 2025 expedited hearing). Petitioner's counsel expended approximately 17.0 hours drafting the entitlement and damages brief and 6.8 hours drafting the responsive entitlement and damages brief, for a combined total of 23.8 hours. ECF No. 43 at 11-12. I find this time to have been reasonably incurred. (And all time billed to the matter was also reasonably incurred.)

Furthermore, Petitioner has provided supporting documentation for all claimed costs, ECF No. 43 at 14-24. And Respondent offered no specific objection to the rates or amounts sought. ECF No. 44. I have reviewed the requested costs and find them to be reasonable.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$28,312.76 (representing \$27,154.30 for attorney's fees and \$1,158.46 in attorney's costs) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.³

³ Pursuant to Vaccine Rule 11(a), the parties may expedite entry of judgment by filing a joint notice renouncing their right to seek review.
