### DECISION AWARDING ATTORNEYS' FEES AND COSTS<sup>1</sup>

On September 9, 2022, Larry Duncan ("Petitioner"), filed a petition in the National Vaccine Injury Program<sup>2</sup> alleging that as a result of receiving an influenza ("flu") vaccine on October 4, 2019, he suffered chronic inflammatory demyelinating polyneuropathy ("CIDP"). Petition at Preamble (ECF No. 1). The undersigned issued a decision based on stipulation on June 12, 2024. Decision dated June 12, 2024 (ECF No. 46).

On December 6, 2024, Petitioner filed an application for attorneys' fees and costs. Petitioner's Application for Attorneys' Fees and Costs ("Pet. App."), filed Dec. 6, 2024 (ECF No. 52). Petitioner requests compensation in the amount of \$36,897.03, representing \$32,327.80 in attorneys' fees and \$4,569.23 in costs. Id. at 1. Pursuant to General Order No. 9, Petitioner certifies that he has expended \$7.75 in pursuit of his claim for compensation. Id. Respondent did not file a response. The matter is now ripe for disposition.

Petitioner requests the following hourly rates for the work of his counsel: for Ms. Leah Durant, \$395.00 per hour for work performed in 2020, \$420.00 per hour for work performed in 2021, \$441.00 per hour for work performed in 2022, and \$486.00 per hour for work performed in 2024; for Christopher Williams, \$341.00 per hour for work performed in 2022, \$358.00 for work performed in 2023, and \$376.00 per hour for work performed in 2024; and for Mr. Mateo Forero, \$385.00 per hour for work performed in 2024. Petitioner also requests the following rates for work of their counsel's paralegals: \$165.00 per hour for work performed in 2021, \$173.00 per hour for work performed in 2022, \$181.00 per hour for work performed in 2023, and \$190.00 per hour for work performed in 2024.

The undersigned finds the rates are consistent with what counsel have previously been awarded for their Vaccine Program work, and finds them to be reasonable herein.<sup>3</sup> The undersigned has reviewed the submitted billing entries and finds the total number of hours billed to be reasonable and will award them in full. Lastly, the undersigned has reviewed the requested costs and finds them to be reasonable and supported with appropriate documentation. Accordingly, the full amount of costs shall be awarded.

Therefore, the undersigned finds no cause to reduce the requested hours or rates, or the requested costs.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of Petitioner's request, the undersigned **GRANTS** Petitioner's motion for attorneys' fees and costs.

**Petitioner is awarded attorneys' fees and costs in the total amount of \$36,904.78 (representing \$36,897.03 for Petitioner's attorneys' fees and costs and \$7.75 for Petitioner's personally incurred costs) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.**

In the absence of a motion for review filed pursuant to RCFC Appendix B, the Clerk of Court **SHALL ENTER JUDGMENT** in accordance with this Decision.<sup>4</sup>

<sup>3</sup> The undersigned will not deduct Petitioner's fees request for billing entries for noncompensable tasks because she finds the overall amount requested reasonable. However, counsel is again warned against billing for filing documents in the future. The undersigned may deduct for this in the future.

<sup>4</sup> Pursuant to Vaccine Rule 11(a), entry of judgment is expedited by the parties' joint filing of notice renouncing the right to seek review.
