DECISION ON ATTORNEY'S FEES AND COSTS¹

On September 15, 2022, Alyssa Tani, filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury as a result of an influenza vaccine she received on October 11, 2021. Petition, ECF No. 1. On December 27, 2023, I issued a ruling on entitlement finding Petitioner entitled to compensation. ECF

No. 32. On March 13, 2025, I issued a decision awarding compensation to Petitioner, following briefing and expedited Motions Day argument by the parties. ECF No. 49.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$65,336.66 (representing \$62,156.10 in fees plus \$3,180.56 in costs). Application for Attorneys' Fees and Costs ("Motion") filed October 8, 2025, ECF No. 57. Furthermore, Petitioner filed a signed statement representing that no personal out-of-pocket expenses were incurred. ECF No. 57-4 at 1.

Respondent reacted to the motion on October 9, 2025, indicating that he is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-3, 3 n.2, ECF No. 59. On October 16, 2025, Petitioner filed a reply requesting that the amount of fees and costs listed in Petitioner's motion be awarded. ECF No. 60.

I have reviewed the billing records submitted with Petitioner's request. The rates requested for work performed through 2025 are reasonable and consistent with our prior determinations and will therefore be awarded herein.

Regarding the time billed, I note this case required additional briefing regarding damages. See Petitioner's Motion for Findings of Fact and Conclusions of Law Regarding Damages, filed Aug. 1, 2024, ECF No. 42; Petitioner's Reply to Respondent's Response to Motion in support of damages, filed Sept. 16, 2024, ECF No. 46. Petitioner's counsel expended approximately 9.10 hours drafting the damages brief and 5.40 hours drafting the responsive brief, for a combined total of 14.50 hours. ECF No. 57-2 at 31-35. I find this amount of time to be reasonable and will award the attorney's fees requested. And all time billed to the matter was also reasonably incurred.

Furthermore, Petitioner has provided supporting documentation for all claimed costs. ECF No. 58-1 at 4-67. Respondent offered no specific objection to the rates or amounts sought. I find the requested costs reasonable and hereby award them in full.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. **Petitioner is awarded attorneys' fees and costs in the total amount of \$65,336.66 (representing \$62,156.10 in fees plus \$3,180.56 in costs) to be paid through an ACH deposit to petitioner's counsel's IOLTA account for prompt disbursement.** In the absence of a timely-filed motion for review (see Appendix B to the

Rules of the Court), the Clerk of Court shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
