DECISION ON ATTORNEY'S FEES AND COSTS¹

On May 30, 2024, Louis Quick filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleged that he suffered a Table injury – shoulder injury related to vaccine administration as a result of his November 21, 2022 tetanus diphtheria acellular pertussis vaccination. Petition, ECF No. 1. On April 23, 2025, I issued a decision awarding compensation to Petitioner based on the Respondent’s proffer. ECF No. 22.

Petitioner has now filed a motion for attorney's fees and costs, requesting an award of \$7,520.84 (representing \$6,872.30 in fees plus \$648.54 in costs). Application for Fees and Costs ("Motion") filed May 19, 2025, ECF No. 26. Furthermore, Petitioner filed a signed statement representing that Petitioner incurred no personal out-of-pocket expenses. ECF No. 26-5.

Respondent reacted to the motion on May 22, 2025, reporting that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. Respondent's Response to Motion at 2-4, ECF No. 27. Petitioner filed no reply thereafter.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates. Furthermore, Petitioner has provided supporting documentation for all claimed costs. ECF No. 26-4. Respondent offered no specific objection to the rates or amounts sought. I find the requested costs reasonable and hereby award them in full.

The Vaccine Act permits an award of reasonable attorney's fees and costs for successful claimants. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$7,520.84 (representing \$6,872.30 in fees plus \$648.54 in costs) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement.** In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk of Court shall enter judgment in accordance with this Decision.³
