### **RULING ON ENTITLEMENT**<sup>1</sup>

On October 3, 2024, Julie Mertz filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she suffered Guillain-Barré syndrome (“GBS”), that developed following an influenza (“flu”) vaccine administered on October 25, 2021. Petition at 1, 3. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 18, 2025, Respondent filed his Rule 4(c) report in which he concedes that Petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, Respondent agrees that Petitioner has satisfied the criteria set forth in the effective Vaccine Injury Table (“Table”) and the Qualifications and Aids to Interpretation (“QAI”), which afford Petitioner a presumption of causation if the onset of GBS occurs

between three and forty-two days after a seasonal flu vaccination and there is no apparent alternative cause. *Id.* at 10 (citing 42 C.F.R. §§ 100.3(a)(XIV)(D), (c)(15)).

**In view of Respondent's position and the evidence of record, I find that Petitioner is entitled to compensation.**
