**DECISION AWARDING DAMAGES**<sup>1</sup>

On October 22, 2024, Maxfel Goodson filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she suffered a Table injury – shoulder injury related to vaccine administration (“SIRVA”) as a result of her pneumococcal vaccination received on March 13, 2024. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On May 9, 2025, a ruling on entitlement was issued, finding Petitioner entitled to compensation for SIRVA. On August 19, 2025, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded \$67,524.98 (representing pain and suffering (\$67,500) and past unreimbursed expenses (\$24.98)). Proffer at 2. In the Proffer, Respondent represented that Petitioner agrees with the

proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$67,524.98 (representing pain and suffering (\$67,500) and past unreimbursed expenses (\$24.98)) to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.<sup>3</sup>

I. Items of Compensation

A. Pain and Suffering

Respondent proffers that petitioner should be awarded \$67,500.00 in pain and suffering.

*See* 42 U.S.C. § 300aa-15(a)(4). Petitioner agrees.

B. Past Unreimbursable Expenses

Evidence supplied by petitioner documents that he incurred past unreimbursable expenses related to her vaccine-related injury. Respondent proffers that petitioner should be awarded past unreimbursable expenses in the amount of \$24.98. *See* 42 U.S.C. § 300aa-15(a)(1)(B).

Petitioner agrees.

II. Form of the Award and Recommended Payments Following Judgement

Petitioner is a competent adult. Evidence of guardianship is not required in this case.

Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment as described below and requests that the Chief Special Master's decision and the Court's judgment award the following:<sup>2</sup>

a lump sum payment of **\$67,524.98 (combination of pain and suffering (\$67,500) and past unreimbursed expenses (\$24.98))**, to be paid through an ACH deposit to petitioner's counsel's IOLTA account for prompt disbursement to petitioner.

These amounts represent all elements of compensation to which petitioner is entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.
