DECISION AWARDING DAMAGES¹

On February 3, 2025, LeAnn Diercks filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleges that she suffered a shoulder injury related to vaccine administration (“SIRVA”) following the influenza (“flu”) vaccine administered on December 28, 2023. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 17, 2026, a ruling on entitlement was issued, finding Petitioner entitled to compensation. On June 9, 2026, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded a total of \$50,000.00, for her pain and suffering. Proffer at 2. In the Proffer, Respondent represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **I award Petitioner a lump sum payment of \$50,000.00 (for her pain and suffering), to be paid through an ACH deposit to Petitioner's counsel's IOLTA account for prompt disbursement to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.³

PROFFER ON AWARD OF COMPENSATION¹

On February 3, 2025, LeAnn Diercks (“petitioner”) filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34, as amended (“Vaccine Act” or “Act”), alleging that she suffered a Shoulder Injury Related to Vaccine Administration (“SIRVA”) following an influenza (“flu”) vaccination on December 28, 2023. Petition at 1. On April 14, 2026, the Secretary of Health and Human Services (“respondent”) filed his amended Rule 4(c) report indicating that, in light of the Chief Special Master’s March 13, 2026 Findings of Fact that petitioner’s symptoms were limited to her vaccinated shoulder, respondent will not continue to defend this case on other grounds during further proceedings on entitlement before the Office of Special Masters. ECF No. 25 at 6; ECF No. 28 at 2. On April 17, 2026, the Chief Special Master issued a Ruling on Entitlement finding that petitioner is entitled to vaccine compensation under the terms of the Act for a SIRVA Table injury. *See* ECF No. 29.

I. Items of Compensation

Based on the evidence of record, respondent proffers that petitioner should be awarded \$50,000.00 in pain and suffering. *See* 42 U.S.C. § 300aa-15(a)(4). Petitioner agrees.

This amount represents all elements of compensation to which petitioner is entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

II. Form of the Award/Recommended Payment

The parties recommend that the compensation provided to petitioner should be made through one lump sum payment as described below and request that the Chief Special Master's decision and the Court's judgment award the following:²

A lump sum payment of **\$50,000.00** to be paid through an ACH deposit to petitioner's counsel's IOLTA account for prompt disbursement to petitioner, LeAnn Diercks.

Petitioner is a competent adult. Proof of guardianship is not required in this case.
